Sub: Merger of Ticket Checking Staff (TC), Commercial Clerk (CC) & Enquiry-cum-Reservation Clerk (ECRC) – continuance of intake of Commercial Apprentices – reg.

The undersigned is directed to refer to draft record note of discussion held on 09.02.2022 (copy enclosed) on the above mentioned subject and to state that the matter has been further examined in consultation with the Commercial Directorate and the Zonal Railways. It has been noticed that the cadre of CMI is merged on certain Railways, while in other, it is not merged. In view of this there may be difficulty in implementing the provisions as contained in the Record Note of discussion dated 09.02.2022.

After reconsideration of the matter, the following proposal has been framed in consultation with the Commercial Directorate:-

(i) Cadre of Commercial Inspector may be merged with Chief Commercial-cum-ticket Clerk on the same lines as in the case of Traffic Inspector enabling inter-operability between the cadre of Commercial Inspector and the cadre of Chief Commercial-cumticket Clerk in Level-6.

(ii) DR at Level-5 may be abolished.

(iii) Educational Qualification for DR in Level-6 may be kept as Graduation.

Draft AVC as per the above proposal is sent herewith. Views of the two recognized federations, i.e. AIRF and NFIR are solicited on the above proposal.

- Continuance of intake of Commercial Apprentices and eligibility of ECRC and Sr. TE in Grade Pay Rs. 2800 (Level-5) for the selection to the post of Commercial Inspector, Grade Pay-4200 (Level-6) against 75% promotional quotas:-
- 4. The official side stated that as demand arises under emerging marketing condition the DR quota of Commercial Apprentice in Grade Pay Rs. 4200, Level-6 may be resumed to enable induction of well qualified candidates from open market. After discussion, the Federations agreed to the following:
- 15% of the cadre of Commercial Inspector (not on merged cadre) shall be filled up by Direct Recruitment of Commercial Apprentice.

(ii) The Educational Qualification for DR may be enhanced from Graduation presently to Graduation plus MBA.

(iii) As the post of CMI requires in depth knowledge of various commercial aspects, the premerged categories of TC/CC/ECRC in Level-5 alone would be eligible for selection to the post of CMI against 75% promotion quota.

(iv) There would be no change in the eligibility condition for 10% LDCE for Commercial Inspector.

The above shall be put up for consideration and approval of Board.
