No. T-16017/11/2019-iGOT dated is" June, 2020 (copy enclosed) and to state that due to the outbreak of COVI D-19 pandemic and in view of the safety measures and the financial austerity, it has been decided that no foreign training shall be conducted by the CPSEs during the current financial year 2020-21.

2. In case, a CPSE proposes to conduct any foreign training under exceptional circumstances, prior approval of DPE must be obtained through the concerned administrative Ministry and DPE will consult DoPT before taking a decision on such proposal.

3. All administrative Ministries/Departments are requested to bring the above instructions to the notice of all CPSEs under their respective jurisdiction for information and immediate compliance.
